## Vancouver Campus Capacity Calculation - Fall 2018

(based on classroom seats only)

There are 1,834 Classroom Seats on campus in 31 classrooms.

There are 2,859 FTE Enrolled at the Vancouver Campus.

There are 24,969 Contact Hours generated by those 1,834 classroom seats.

### Formula is:

# of Seats times HECB Standard
# of Contact Hrs divided by Enrollment #

# of times the seats can be used to meet the standard # of contact hours each FTE generates in classroom seats

 4,620 Campus FTE Capacity

 24,969 / 2,859
 8.733 to get to HECB Standard Hrs.

If the campus has a classroom capacity of 4,620, but

there are only 2,859 FTE currently on campus, then,

the campus could grow an additional 1,761 FTE using the existing classroom seats to meet HECB Standard.

Current space is being used at 62% of the HECB Standard. = 13.61 / 22 = 62.0%
